MONROVIA, INDIANA

Ordinance 2021-11 adopted November 23, 2021, establishing Town employee compensation effective
January 1, 2022 is hereby amended as follows:

Appointed Officers – Town Marshal:

Added (specific to Town Marshal): Paid Health/Medical Benefits at a cost not to exceed
\$7,000 annually (average of \$583.33 monthly)






Inspector - Town Building Inspector:

Added: Stipend of \$750.00 to be paid at the end of each calendar year.

Elected Official - Clerk Treasurer

Corrected: Bi-weekly amount in General Fund column amended to reflect \$363.46

**AN ORDINANCE ESTABLISHING SALARY AND COMPENSATION
FOR EMPLOYEES AND ELECTED OFFICERS**

WHEREAS, IC 36-5-3-2 states the town legislative body shall fix the compensation of its own members, the Town Clerk Treasurer, the Town Marshal and other town officers and employees.

WHEREAS, the Town Council wishes to establish the salaries that shall be effective January 1, 2022.

Therefore, be it ordained by the Town Council that the following salary schedule shall be in full force and effect for pay dates after January 1, 2022, inclusive of all dates in pay period regardless of year the days fall.
