**RESOLUTION TO ADOPT THE TOWN OF MONROVIA, INDIANA 2024 – 2028
PARKS AND RECREATION MASTER PLAN WITHIN THE TOWN OF MONROVIA,
MORGAN COUNTY, INDIANA**

WHEREAS, the Town Council of the Town of Monrovia (hereinafter “Council”) serves as its legislative body in accordance with I.C. § 36-5-2-2; and the President of the Town Council (hereinafter “President”) serves as its executive in accordance with I.C. § 36-5-2-7; all of which authority is derived from I.C. § 36-1 eq. seq. and I.C. § 36-5 et. seq.; and,

WHEREAS, the Monrovia Town Council is aware of the parks and recreation needs of the residents of Monrovia, Indiana; and,

WHEREAS, the Monrovia Parks and Recreation Board has undertaken the development of a five (5) year Parks and Recreation Master Plan which describes the physical features, existing recreation facilities/amenities, and the desired actions to be taken to improve, maintain, and expand recreation facilities during the period between 2024 and 2028; and,

WHEREAS, a public hearing was held at the regularly scheduled Parks and Recreation Board meeting on July 16, 2024 to express opinions, ask questions, and discuss all aspects of the Parks and Recreation Plan, and,


WHEREAS, the Monrovia Parks and Recreation Board voted unanimously to support said plan.




